

Nomi Payroll Promotion

Terms and Conditions

1. Promotion Period

This payroll promotion is valid from 16th March 2026 to 30th April 2026 (both dates inclusive). Sign-ups made outside this period will not qualify for the discounted rate.

2. Offer Details

During the promotion period, new customers who sign up for a 12-month Nomi payroll subscription will receive 50% off the standard monthly subscription fee for the first 6 months of their contract.

3. Eligible Services

The offer applies exclusively to Nomi's Payroll subscription service. It does not apply to any other Nomi services, including but not limited to:

- Bookkeeping
- Final Accounts
- Self-Assessment

4. How the Discount Works

Qualifying customers will pay 50% of the standard monthly payroll subscription fee for months 1–6 of their 12-month contract. From month 7 onwards, the full standard monthly subscription fee will automatically apply for the remainder of the contract term.

Example: If the standard monthly payroll fee is £100/month, the customer pays £50/month for months 1–6, then £100/month for months 7–12.

5. Commitment Requirement

To qualify for this promotion, customers must sign up for a minimum 12-month subscription. This promotion is not available on monthly rolling or short-term contracts.

6. Applying the Offer

No promo code is required at the point of sign-up. The Nomi sales or support team will manually apply the discounted rate to your account once your subscription has been processed. The discount will be reflected in your invoices for months 1–6.

7. Eligibility

This promotion is available to business owners who are new Nomi payroll customers only. It is not open to bookkeepers, accountants, or accounting practices signing up on behalf of clients. Existing Nomi payroll subscribers and customers who have previously held a Nomi payroll subscription are not eligible. Business owners currently on a free trial may participate provided they convert to a paid 12-month subscription within the promotion period.

8. Transition to Full Price

At the end of month 6, the subscription fee will automatically revert to the full standard monthly rate. No separate notification will be issued prior to this change. Customers are advised to note this date at the time of sign-up. The remaining 6 months of the 12-month contract will be billed at the full standard rate.

9. Non-Eligible Sign-Ups

Sign-ups completed on or after 1st May 2026 will not qualify for the promotional discount. Standard payroll subscription pricing will apply.

10. Combining Offers

This promotion cannot be combined with any other Nomi discounts, offers, or promotions unless explicitly stated in writing by Nomi.

11. Refund Policy

Standard Nomi refund and cancellation terms apply. Early termination of the 12-month contract may result in the full standard subscription fee becoming payable for any months benefiting from the promotional discount. Please refer to Nomi's standard Terms of Service for full details.

Nomi reserves the right to amend, extend, or withdraw this promotion at any time without prior notice. Any such changes will not affect customers who have already signed up and had the promotional rate applied to their account.
